The committee is responsible for the overall management and smooth running of the Pre-school. This can mean anything from organising a fundraising event to supporting and working with the setting manager in recruiting, training and developing staff.

Volunteering for your pre-school's parent-run committee offers a great opportunity for you to become more actively and practically involved in this aspect of your child's life. You can also have an impact and say about how the setting is managed. There are lots of ways that you can contribute to the committee and you can choose to give as much or as little time as you would like. The good thing is you don't need any experience to make a difference and you may find it a good way to update existing skills and learn new ones.

The committee meet once every term or as and when needed depending on the needs of the Pre-school.
